The submission/filing date for rezonings, special exceptions, etc. falls on the 3<sup>rd</sup> Wednesday of the month unless otherwise noted. **15 DAYS** prior to the advertised date of the public hearing **ALL REVISIONS AND PROFFERS MUST BE SUBMITTED**. The TRC committee meets on the 1<sup>st</sup> Wednesday of each month. All applications except variances/appeals go to the TRC. The Planning Commission meets on the 3<sup>rd</sup> Wednesday of each month except for December when their meeting falls on the 2<sup>nd</sup> Wednesday. The Board of Supervisors holds its public hearings on the 4<sup>th</sup> Tuesday of each month (\*\*except in December when there is only 1 meeting). The Board of Zoning Appeals meets on the 2<sup>nd</sup> Thursday of each month. (\*) Dates altered due to holidays.
